Regulation 14 update: C. Exley reported

C. Exley reported that the Writing group had met twice since the last Steering group meeting and have continued to work on the text in different sections. Comments on the outstanding Reg. 14 responses have been received from Ian, which have now been worked through and have been forwarded to the Steering group for approval. Policies are the key and must be watertight. There will be some changes to lists as a result, e.g. greenspace, non-designated heritage assets and community facilities - some additions, some deletions as they have to fit in with definitions and we have to be able to justify them all.

- Once all the sections are complete they will be collated and the full track-changed Plan will be put onto the website, along with the Reg. 14 responses.
- Paul Exley will liaise with Sam on producing a clean copy.
- Volunteers for proof-reading will be required for grammar and typographical errors.
- Final changes will be made.

We need to keep making progress if we are to reach the timetable for the referendum later this year.

19/02248 Sport England have unresolved issues including the reprovisioning before any development started.
