Regulation 14 and Plan Update: B. Flynn reported that the Writing Group had met with Ian Mackay to discuss the Plan and learned that 2 LCC employees were looking at the Plan with a view to making changes. The Writing Group were unlikely to make wholesale changes at this stage but any discrepancies or inaccurate information would be corrected.

Ian also suggested that it would be necessary to raise the profile of the GNPF prior to the referendum but did not think it necessary for leaflets to be delivered to every household in Garforth.

A decision would also have to be made as to whether the GNPF would produce the final Plan themselves or employ a professional graphic designer. Barwick had employed a professional and Clifford had produced their Plan themselves. Both had proved acceptable to the Inspector.

After being accepted by the Inspector some hard copies would have to be printed for the library and residents unable to access the internet.

Action: Sam to have a look through both the Barwick and Clifford Plans to ascertain differences of presentation between the professional and the DIY Plans.
